Clinical trials remain an essential component of Oncology patient care and each site is proactively addressing how to support trial activity under these new and unprecedented conditions.


Sites have been collaborating with each other to determine how to respond to:

- Workforce Considerations to support ongoing trials and the best use of shared resourcing

Sites are also assessing their resources to support the implementation and ongoing management of COVID-19 clinical trials.



## Site Metrics

Between Jan 2018 - Dec 2019:

- **654** regional patients have been recruited
- **104** new cancer clinical trials open

#### MRFF GRANT APPLICATION

The RTN Project Team submitted an application for ongoing funding to support regional sites.

#### **AN UPDATE**

The Australian Commission on Safety and Quality in Health Care released the draft National Clinical Trials Governance Framework in March 2020.

The Commission will select and announce sites for the Pilot program in **June 2020** with the program to commence in **July-August 2020.**
